- Documents to support identity and address should be updated in **Aadhaar** after every 10 years from date of enrolment for **Aadhaar**.
- **Aadhaar** helps you avail of various Government and Non-Government benefits/services.
- Keep your mobile number and email id updated in **Aadhaar**.
- Download mAdhaar app to avail of **Aadhaar** services.
- Use the feature of Lock/Unlock **Aadhaar** biometrics to ensure security when not using **Aadhaar** biometrics.
- Entities seeking **Aadhaar** are obligated to seek consent.
