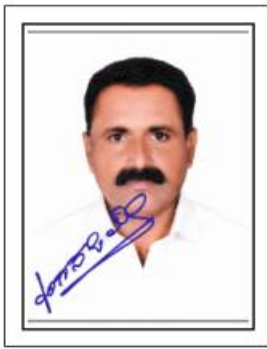

- #** Use the feature of Lock/Unlock Aadhaar-Biometrics to ensure security when not using Aadhaar-Biometrics.
- #** Entities seeking Aadhaar are obligated to seek consent
